

Memorandum of Understanding (MoU)

This memorandum of understanding (MOU) between M. M. H. Arabic & Persian University, Patna and FERHAT MURTAZA FOUNDATION, SONIHAR, KHAGARIA is with regards to acceptance of terms and conditions for the conduct of Academic Programme of MMH A & P University. The name of the Academic programme as per annexure: -

- (i) The objective of this MOU is to bring about innovative methods of teaching and learning by sharing available resources with different organizations, so that the benefit of quality teaching is provided to the disadvantaged and deprived sections of students. Such MOUs will be within the limitation of the Bihar State University Act 1976 amended up to date.
- (ii) Resolved that M. M. H. Arabic & Persian University, Patna and FERHAT MURTAZA FOUNDATION, SONIHAR, KHAGARIA will co-ordinate and collaborate through sharing of resources for the conduct of mutually agreed academic programmes of the University.
- (iii) Both institutions agree to share their physical infrastructure, human resource, teaching and learning material within the objectives and limitations of their own act and statute, if any, as well as any rules or regulations.
- (iv) The academic programme of MMH A & P university such as degree, advanced diploma courses as well as certificate courses shall be conducted jointly in accordance with mutual understanding without putting any financial burden upon the university but the university may meet such financial burden with the approval of the finance committee or any other competent authority of the university and the governing body/ managing committee/ Executive council/ committee of the institution with whose collaboration the academic programme of the University shall be carried out.
- (v) FERHAT MURTAZA FOUNDATION, SONIHAR, KHAGARIA will be providing the necessary Library, Laboratory facilities if available to the enrolled student/ Researchers on payment or free of cost as decided by the Executive Council/ governing body of the organization.
- (vi) In no case the university or the collaborating organization will take the liability of appointment absorbing any of the staff members engaged in the conduct of the courses. Staff requirement of any courses will be decided by the University and they will engage as per the rule of the university.
- (vii) Both the parties agree to conduct the academic programme jointly and Diploma/ Degree certificate will be awarded by the University as per the approved ordinance/ Regulations.
- (viii) This MOU is signed between the M. M. H. Arabic & Persian University, Patna and FERHAT MURTAZA FOUNDATION, SONIHAR, KHAGARIA on 09/04/2025 in the interest of educational development in the state.
- (ix) The University shall reimburse the cost of teaching learning material out of the fee collected subject to a maximum amount of 80% of the total net income.
- (x) Modalities of admission will be decided by the University for each Course as per its Admission Ordinance and/ or decision of the university.
- (xi) FERHAT MURTAZA FOUNDATION, SONIHAR, KHAGARIA agrees to make available its library to the students enrolled in Academic Programme/Voc. Courses.
- (xii) Academic programme will follow the approved ordinance/Regulation of the university. Such terms and conditions including regulation/ ordinance shall be subject to change and/ or amendment.

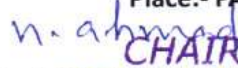
